Regarding the announcement of the establishment of Thai Smile Airways Co., Ltd. ("Thai Smile") as stated in the attached letter, Thai Airways International Public Company Limited ("the Company") would like to inform that, on 24 September 2013, the Cabinet has made a resolution for the Company to set up Thai Smile as a subsidiary company with 100% shareholding under a status of a state enterprise. On 17 October 2013, Thai Smile was set up with a registered capital of Baht 1,800 million, divided into 180 million ordinary shares at 10 Baht per share par value. Thai Smile is funded by the Company's 2013 revenue of Baht 450 million and 2014 revenue of Baht 1,350 million.
